General Information

Description	The monoclonal antibody ER-MP58 recognizes an antigen present on all mouse macrophage colony-stimu (M-CSF) responsive cells in the bone marrow, including the earliest colony-forming myeloid progenitors, at the majority of other myeloid precursors. The antigen is detected on a broad development range of recursor cells to the monocytic level, but also on granulocytes. Expression is rapidly lost upon maturation monocytic stage. The antigen disappears in the course of macrophage differentiation. Furthermore the clearly different from commonly used myeloid markers as Mac-1, F4/80, and Gr-1. The monoclonal antibody ER-MP58 is very useful for the identification of mouse myeloid hematopoieti various organs, and for embryonic studies.
